I respectfully request funding for the Nacogdoches Downtown Parking Garage Project in fiscal year 2027. The entity to receive this funding is the City of Nacogdoches, located at P.O. Box 635030, Nacogdoches, Texas 75963.

This \$5,000,000 request would be used to construct a multi-level parking facility in downtown Nacogdoches to address current and projected parking demand and support ongoing redevelopment efforts. The project will enable increased utilization of existing buildings and support job creation associated with new commercial investment.
