I respectfully request funding for the State Highway 45 Pump Station Project in Fiscal Year 2026. The entity to receive this funding is the City of Pflugerville, Texas, located at 15500 Sun Light Near Way, Pflugerville, TX 78691.

This project will provide funding for a new 5.0-MGD pump station and 1.25-MG ground storage tank in the northwest corner of the intersection of State Highway 130 and State Highway 45 serving the 960' Pressure Zone. This project will provide additional pumping capacity to serve growth in zone. This project supports the Safety, Infrastructure and Services pillars of the Strategic Plan and Comprehensive Plan by providing a safe, resilient infrastructure for our citizens. My community project funding request for this project is \$1,700,000.
