Dear Chairman Cole and Ranking Member DeLauro,

I respectfully request funding for the Old McGregor–Ritchie Road Improvements Project in fiscal year 2027. The entity to receive this funding is the City of Woodway, located at 924 Estates Drive, Woodway, Texas 76712.

This \$1,750,000 request would be used to reconstruct and improve two major roadway corridors, including widening pavement, upgrading drainage systems, relocating utilities, and adding sidewalks and safety features. These roads currently experience significant congestion and deterioration due to rapid growth and increased traffic volumes.

The project is an appropriate use of taxpayer funds because it improves public safety, reduces congestion, enhances access to employment centers, healthcare facilities, and schools, and supports economic activity across multiple jurisdictions within McLennan County.

The project has a federal nexus because the funding provided is consistent with purposes authorized in 42 U.S.C.5305(a)(1), 5305(a)(2), 5305(a)(4), and/or 5305(a)(5).
